## Poletop Rescue Training Tests Linemen's Lifesaving Skills

very year, East Central Electric (ECE) linemen devote a full day to preparing for the event they hope never arrives. The coop's annual pole top rescue training evaluates each lineman on their ability to rescue an injured or stranded lineman. This year, the training took place on October 6 at ECE.

The OSHA-mandated safety training course requires each lineman to buckle on fall restraint equipment belts and climbing spikes, and ascend a utility pole to rescue a 185-pound mannequin. A safety instructor from the Oklahoma Association of Electric Cooperatives

evaluates every step of the process from the ground. Each step requires both skill and safety awareness, and must be completed within three minutes. The lineman must climb the pole, secure the mannequin using ropes and pulleys, and safely lower it to the ground. Afterward, the instructor discusses his findings with the linemen.

Because linemen work around dangerous voltages every day, safety is "priority one" at ECE. Pole top rescue training is just one example of ECE's ongoing commitment to keeping its employees and the general public safe.

#### **Sweet Potato Casserole**

#### **INGREDIENTS**

4 cups sweet potato, cubed ½ cup white sugar 2 large eggs eggs, beaten ½ teaspoon salt 4 tablespoons butter, softened

1/2 cup milk
1/2 teaspoon vanilla extract
1/2 cup packed brown sugar
1/3 cup all-purpose flour
3 tablespoons butter, softened

#### **DIRECTIONS**

Preheat oven to 325 degrees F. Put sweet potatoes in a medium saucepan with water to cover. Cook until tender; drain and mash.

In a large bowl, mix the sweet potatoes, white sugar, eggs, salt, butter, milk and vanilla extract until smooth. Transfer to a 9x13 inch baking dish.

In medium bowl, mix the brown sugar and flour. Cut in the butter until the mixture is coarse. Stir in the pecans. Sprinkle over the sweet potato mixture in the baking dish.

Bake in oven 30 minutes, or until the topping is lightly brown.
