A MESSAGE TO OUR MEMBERS



That's Value

In 1938, East Central Electric members paid **8.5 cents** per kilowatt-hour (kwh), which amounts to roughly **\$1.50 cents/kwh** in today's dollars. Instead, cooperative members pay a little over **11 cents/kwh**, and enjoy some of the lowest residential electric rates in Oklahoma.

Ahead: Better Service For You

Wouldn't it be nice if all of our business decisions were based on the telepathic ability to see into the future? Knowing what lies ahead would allow us to better plan and allocate resources, prepare for disasters, and provide services to our members before they even realize they need them. Chances are we will never have a crystal ball, but soon your electric cooperative will be better able to predict, and sometimes avoid power outages altogether.

The reason lies in one of the most groundbreaking decisions your board of trustees has ever made: By approving the installation of fiber optic cable throughout our 6,288-mile electric system, East Central Electric will take a giant step toward grid modernization and better utilization of electric grid technology.

Fiber optic communications will let us see and monitor our regulators, capacitors, switches and more in real time. The ability to track and control these devices from the office allows us to better understand and fine-tune our electric system performance. Once we can see and communicate with our equipment down the line, we can begin to move toward engineering and planning a self-healing grid. As a result, members will experience fewer and shorter outages. Operations efficiency will improve, and our cooperative employees will spend less time driving our lines in terrible weather searching for the source of a problem.

Reliable and affordable service remains the primary mission and purpose of East Central

Electric Cooperative, but our values include concern for the broader needs of our communities. Thanks to the long-sighted vision of your elected trustees, your cooperative-owned fiber optic network will meet needs beyond the meter by bringing the most advanced, high-speed Internet and telephone service to our service area at an unbelievably low monthly price.

When East Central Electric began over 81 years ago, rural residents lacked the basic amenities—lights, indoor plumbing and running water—that their counterparts in town enjoyed. Other companies refused to extend electric service to rural areas, and as a result, the rural lifestyle remained primitive. By forming a cooperative and building power lines to places no one else thought was possible, our founding members conveyed a clear vision for the future that still drives your cooperative today. As we step forward to bring fiber optic broadband service to rural areas, our focus, like that of our co-op founders, remains on meeting the unserved needs of our members. Like the first electric lights on the farm, we believe the results will be lifechanging.


The books and financial statements of East Central Oklahoma Electric Cooperative, Inc. are audited each year as of December 31. An audit for the year ended December 31, 2018 has been completed by the firm of Briscoe, Burke & Grigsby LLP, Certified Public Accountants, Tulsa, OK. The Comparative Financial Statements shown here are for the years ended December 31, 2017 and 2018. East Central Electric's balance sheet reflects a 4.36 percent increase in assets. Capital credits and membership fees increased by \$2,218,585, which gave our members an equity level of 48.98 percent.
